

WELCOME TO CFH BREAKS PUBLIC ACCESS AREA

THE VIRGINIA DEPARTMENT OF WILDLIFE RESOURCES WELCOMES YOU TO THIS AREA. THESE LANDS ARE MANAGED UNDER A COOPERATIVE AGREEMENT WITH CF HIGHLANDS LLC AND ITS LAND MANAGER THE NATURE CONSERVANCY. TO ENSURE CONTINUED PUBLIC ACCESS TO THESE PRIVATE LANDS, PLEASE RESPECT THE FOLLOWING RULES:

- **GENERAL**

A STATE HUNTING OR FISHING LICENSE **IS REQUIRED** TO ENTER THIS PROPERTY TO HUNT OR FISH.

DISPLAY OR CONSUMPTION OF ALCOHOLIC BEVERAGES IN PUBLIC IS PROHIBITED.

ROADS, TRAILS OR SECTIONS OF THE PROPERTY MAY BE TEMPORARILY CLOSED TO PUBLIC ACCESS. OBEY SIGNS.

- **HUNTING REGULATIONS**

PLEASE REFER TO THE CURRENT *HUNTING & TRAPPING IN VIRGINIA* DIGEST AND ALL POSTED RULES FOR ANY SPECIAL SEASONS AND BAG LIMITS THAT MAY APPLY TO THIS COUNTY AND THIS AREA. COYOTE HUNTING ALLOWED FROM SEPTEMBER 1 THROUGH MARCH 10 AND DURING SPRING TURKEY HUNTING SEASON. TRAPPING PROHIBITED.

- **FIREARMS**

IT IS UNLAWFUL TO HAVE IN POSSESSION A FIREARM OR HUNTING WEAPON THAT IS NOT UNLOADED AND CASED OR DISMANTLED EXCEPT WHEN IT IS LAWFUL TO TAKE BEAR, DEER, GROUSE, PHEASANT, QUAIL, RABBIT, RACCOON, SQUIRREL, TURKEY, OR WATERFOWL OR MIGRATORY BIRDS; OR BY PERMIT ISSUED BY THE DEPARTMENT; OR BY CONCEALED CARRY PERMIT ISSUED BY A CIRCUIT COURT.

IT IS UNLAWFUL TO POSSESS OR TRANSPORT A LOADED GUN IN OR ON ANY VEHICLE AT ANY TIME ON THIS AREA.

TARGET SHOOTING IS NOT PERMITTED.

- **FISHING AND SWIMMING**

PLEASE REFER TO THE CURRENT *VIRGINIA FRESHWATER FISHING REGULATIONS* DIGEST AND POSTED SIGNS FOR ANY SPECIAL CREEL AND SIZE RESTRICTIONS THAT MAY APPLY TO THIS AREA.

SWIMMING IS PROHIBITED.

- **CAMPING AND FIRES**

NO CAMPING IS ALLOWED ON THIS PROPERTY. NO FIRES ARE PERMITTED ON THIS PROPERTY.

- **DOGS**

IT IS LAWFUL TO CHASE WITH DOGS OR TRAIN DOGS ON THIS AREA ONLY DURING AUTHORIZED HUNTING, CHASE OR TRAINING SEASONS THAT SPECIFICALLY PERMIT THESE ACTIVITIES. BEAR AND RACCOON HOUND TRAINING SEASON DATES FOR PUBLIC LANDS APPLY TO THESE LANDS. NO TRAINING ALLOWED FOR RABBIT, SQUIRREL OR BIRDS OUTSIDE HUNTING SEASONS.

DOGS MUST BE LEASHED AT ALL TIMES OUTSIDE OF OPEN HUNTING, CHASE, OR TRAINING SEASONS.

- **VEHICLES**

HIGH CLEARANCE 4x4 VEHICLES RECOMMENDED. PARKING PERMITTED ON ROADSIDES PROVIDED DRIVER LEAVES SUFFICIENT SPACE FOR SAFE PASSAGE OF LARGE TRUCKS AND EQUIPMENT. DO NOT DRIVE OVER OR PARK ON GAS LINES. DO NOT BLOCK ACCESS TO GAS FACILITIES INCLUDING BUT NOT LIMITED TO WELLHEADS, VALVES, PUMP JACKS, STORAGE TANKS, CONTAINMENT STRUCTURES AND COMPRESSOR SITES.

MOTOR VEHICLES ARE PROHIBITED BEHIND BARRICADES OR GATES DESIGNED TO PREVENT ENTRY OR WITHIN AREAS OTHERWISE POSTED TO PROHIBIT MOTOR VEHICLES. DO NOT BLOCK GATES OR ROADS.

OPERATION OF ATVs AND UTVs IS PROHIBITED, EXCEPT BY PERMITTED RIDERS OPERATING ON SPEARHEAD TRAILS. ALL SPEARHEAD TRAILS RULES MUST BE FOLLOWED [HTTPS://.SPEARHEADTRAILS.COM/RULES-FAQS/](https://spearheadtrails.com/rules-faqs/) TRAILS MAY ONLY BE ACCESSED AT TRAILHEADS

CROSS-COUNTRY MOTOR VEHICLE TRAVEL (OFF-ROAD OR OFF-TRAIL TRAVEL) IS PROHIBITED.

MOTOR VEHICLES AND TRAILERS MAY BE PARKED ON THIS LAND ONLY WHEN THE RESPONSIBLE PARTY IS ENGAGED IN AUTHORIZED ACTIVITIES.

- **HORSEBACK AND BICYCLE RIDING**

HORSEBACK RIDING AND BICYCLE RIDING ARE PROHIBITED EXCEPT ON SPEARHEAD TRAILS DESIGNATED FOR THESE USES

- **RESOURCE AND PROPERTY DAMAGE**

IT IS UNLAWFUL TO CONSTRUCT OR OCCUPY ANY PERMANENT STRUCTURE (INCLUDING A PERMANENTLY AFFIXED TREE STAND).

IT IS UNLAWFUL TO CUT, MUTILATE, DESTROY OR REMOVE VEGETATION, DIG GINSENG OR OTHER HERBS OR FLOWERS ETC. OR TO REMOVE MINERALS, ARTIFACTS OR OTHER PROPERTY FROM THE AREA. METAL DETECTING AND ARTIFACT HUNTING ARE PROHIBITED.

PICKING OF MUSHROOMS AND BERRIES FOR PERSONAL USE IS ALLOWED.

IT IS UNLAWFUL TO DAMAGE, DEFACE, OR REMOVE ANY BUILDING, GATE, FENCE, SIGN, OR OTHER PROPERTY.
